The bids will be opened in the presence of Bidders' representatives who choose to attend at Feb.14, 2018 (Falgun 02, 2074) at 14:00 hours at the office of Chandannath Municipality, Jumla Bids must be valid for a period of 120 days after bid opening and must be accompanied by a bid security, amounting to a minimum of NRs.120806.66(One lakh twenty thousand eight hundred six rupees and sixty six paisa only), and estimated cost is 4276341.78(forty two lakh seventy six thousand three hundred forty one rupees and seventy eight paisa) Exclusive VAT. Which bid security shall be valid for 30 days beyond the validity period of the bid .
8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
